## Terms and Conditions for Auction of Cashew Crop from Government Farms of Directorate of Agriculture for the year 2023

1. Open auction of **'Cashew Crop'** for the year 2023 at Government Farms shall be held as shown below:

- 2. Interested persons would be required to register themselves for participation in auction by depositing an amount of **Rs.1000/** in cash with the concerned Office on the date of auction.
- 3. The deposit of **Rs.1000/** of successful bidder shall be retained till the end of the cropping season **15/06/2023** as security deposit and will be refunded thereafter.
- 4. The deposit of unsuccessful bidder will be released after finalization of the auction process on the same day.
- 5. The successful bidder shall furnish 50% of the bidded amount after finalization of the auction before close of the Office hours on the same day or latest by next day before 12.00 noon (working day).
- 6. The successful bidder shall pay the balance amount to make up 100% of the quoted amount within five working days from the date of the auction at the concerned Office.

- 7. If the successful bidder fails to deposit the balance quoted amount within the prescribed period, his deposit and 50% payment done shall be forfeited in favour of the Government and the bidder will lose his right to the bid/crop.
- 8. The auction will be limited to the cashew crop only for Kalay and Codar Farm whereas; for Pernem Farm in addition to cashew crop mango and other fruit bearing trees like kokum and jackfruit are also included. The bidder will have no right to any other crops, material, wood etc; or any other trees existing in the area.
- 9. The successful bidder will take full care and responsibility for proper maintenance and protection of the cashew trees from the damages by theft, fire etc. In case of default the losses occurred to Government property, trees, crops etc; would be evaluated by the concerned Office and the cost thereof would be recovered from the bidder. The bidder shall pay this cost to the concerned Office.
- 10. The successful bidder shall not indulge himself in any of the plots other than cashew trees put for auction and would not obstruct the smooth running of the Farm.
- 11 The deposit of the bidder maintained with the concerned Office shall be forfeited in favour of the Government in case of failure of the bidder to pay for the losses occurred.
- 12. The crop stand at the concerned Farm could be inspected by interested parties/bidders with the permission of the concerned Office before the start of the auction process during the working days and working hours.
- 13. The Director of Agriculture, Tonca, Caranzalem-Goa reserves the right to terminate the auction awarded to any of the bidder at any time if gross negligence, mis-management and damages to the Government property are noticed.
- 14. The Directorate of Agriculture reserves the right to collect the scion material from the yielding or non yielding trees on the Farm during the period of auction/exploration.
- 15. The successful bidder shall be required to make appropriate arrangement of watch and ward of the crop allotted for auction/exploration at his cost. He shall also make his own arrangement for stocking of tools, equipments and produce at his level.
- 16. The Director of Agriculture reserves the right to accept or reject any or all the bids without assigning any reason thereof.
